Manager and Henrietta Dover Castle Bonett wife of  
George Bonett of Langhorne's Creek Farmer in equal  
shares each sharing alike all and every my  
household furniture linen and wearing apparel  
books plate pictures china horses carts carriages  
and also all and every sum and sums of money  
which may be in my house or be about my person  
or due to me at the time of my decease and  
also all other my stocks funds securities  
for money book debts money on bonds bills  
notes or other securities and all and every  
other my estate and effects whatsoever and  
wheresoever both real and personal whether in  
possession reversion remains or expectancy I  
hereby direct notwithstanding the direction  
hereinbefore contained I hereby give unto my son  
Edwin Jeff John Jeffreys the sum of Two hundred

and Seventy pounds <sup>745</sup> being moneys left to him  
and owing to me to and for their own use and  
benefit absolutely And I nominate Constitute  
and appoint Christina Payne of Semaphore  
Widow to be Executrix of this my last will and  
hereby revoking all former or other Wills and Testaments  
by me at any time heretofore made I declare  
this to be my last will and Testament In  
witness whereof I the said Ann Jeffreys otherwise  
known as Ann McLean Jeffreys have to this my  
last will and Testament set my hand the  
twenty second 22<sup>nd</sup> day of May in the year of  
our Lord one thousand nine hundred and two (1902)
