FINANCIAL STATEMENT.

Alf McLean, Honorary Secretary/Treasurer, advised that audited accounts would be submitted when Mr. N. Lee, selected to provide audit examination, returned from Queensland in September.

BUSINESS SUBMITTED BY CHAIRMAN.

This item of business was nominated by former President Laurie McLean, at last meeting but no submission re same had been made by him.

Members discussed that some family reunions were held every year, others longer intervals. Sometimes open air reunion gatherings were planned on 1-day basis. It was noted that more frequent reunions enabled family members to get to know one another better. Travelling distance is also a factor to be kept in mind.

 $\underline{\text{RESOLVED}}$ that further discussion on this be deferred.

CONSTITUTION.

Draft constitution submitted by former President Laurie McLean was examined, and then in conjunction with a constitution submitted by Jack McLean.

The following alterations and additions or deletions were made to draft constitution under review;-

RESOLVED that "COUNCIL OBJECT" at bottom of Article 2 be deleted, together with Article 4. (9) DUTIES OF PRESIDENT. Article 5. (1) DUTIES OF TREASURER & Article 6. (1) DUTIES OF SECRETARY.

MOVED Marie Keller, seconded Jack McLean. CARRIED.

RESOLVED that Article 9. (2) APPOINTMENT OF PIPERS be deleted.

MOVED Marie Keller, seconded John Malycha.

CARRIED.

 $\underline{\text{MOVED}}$ Jean Bowles "that a Committee be appointed to investigate the Constitution" Lapsed for want of a seconder.

RESOLVED that Article 4. MANAGEMENT. (1) to (9) (referring to first (9) as there are two) be deleted, and following Clauses 5. OFFICERS, & 6. MONIES in the Milang Historical Society be substituted in lieu thereof.

RESOLVED that under BY LAWS existing Clause (7) be amended by addition of words "without good cause" after word "meetings" in the second line, and that clauses (1) & (2) be deleted, and the BY LAWS paragraph be re-numbered accordingly.

RESOLVED that Clause 8 CHANGING THE CONSTITUTION and Clause 9 DISBANDMENT OF THE SOCIETY, from constitution of the Milang Historial Society be added to end of the draft constitution with deletion of c) from Clause 8 and substitution of National Trust Museum, Strathalbyn in lieu of Strathalbyn District Council in Clause 9.

BANK AUTHORITY.

RESOLVED that under the above heading, the following paragraph be added "All payments other than Petty Cash, shall be made by cheque. Two signatures are required for all cheques. Signatories to be President, Secretary and Treasurer or any two Committee Members.

I have obtained necessary forms, details, etc, from the Corporate Affairs Commission, and could proceed with obtaining Incorporation as soon as this is decided upon. Fees:- About \$70.00.

GENERAL BUSINESS:

NOTE.

A short memo prepared by Alf McLean is attached hereto. It is intended to issue a newsletter to all family members as soon as various issues have been decided upon.

I may have indicated at the last Committee meeting held on 19/6/88 that I intended to circulate a "Newsletter" to all family members, arising from that meeting. However, on considering the cost and the fact that the next meeting will hopefully decided on some issues - I have not prepared another "Newsletter".

We can go ahead to seek In-Corporation as soon as the form of a Constitution is decided upon. I would suggest the Constitution be written as concisely and briefly as possible. Explanatory attachments can be issued with it if desired, to cover purely domestic views of the Committee,

i.e. with reference to consideration of persons, facts, etc.

or dealing with contentious matters.

these sort of matters not usually set out in a constitution.

But if it is decided to write verything into the Constitution, I don't see any real impediment to doing it, except that perhaps including great detail on "assurances of delicacy" in constitution, could impede writing of McLean book. What do you do if in writing an interesting narrative involving some family member in the past, a present day descendant claims it is embarrassing? Then claims the Constitution is being breached!

McLEAN BOOK

I would like to see definite plans and discussion on how we see this being done. I see it being divided up into as many smaller segments as possible, with not neccesarily present day descendants doing their family line or part of it.

The job needs to be divided up into as many different tasks as possible, literary ability is not required - this can be done later.

The primary task is to see how much family tree, and anecdotal private details of individual history can be unearthed.

NEW BUSINESS.

Alf McLean referred to agenda comment on organization and possible book publication, and outlined on a separate page some heading for discussion.

President Laurie raised the unproven facts as to exactly how many family members comprised the family of Donald and Christina McLean. There is mention of Ewan & Donald, at present unproven. Hugh the elder on ship "Tomatin" Hugh the younger.

Marie Keller said that her line was from Hugh the younger, quite a bit of knowledge existed on this family line but history for book publication was scanty.

Jim Poole represented the Allan Line, as does Rosemary Bonner and many others. It is not expected that any difficulty will occur in history, but as it extends to Western Australia, work is required to extend the knowledge.

Jack McLean for John line said that a lot of information existed, but a lot of his children had not been traced.

Jennie Lee referred to a book "Yesterday for Tomorrow" published by Investigator Press, author Margaret E. Ragless, was worth considering in regard to family hisotry matters.

President Laurie mentioned that he was seeking to establish the oldest family person, Eva Congden at present.

Many aspects raised on page 2 of the agenda were not discussed, due to time being needed to consider same.

MEMBERSHIP YEAR.

Moved Marie Keller, seconded Jean McLean, that the FAMILY MEMBERSHIP year be from 1/1/88 and thereafter on 1st January each year. CARRIED.

FAMILY LINE RELATIONSHIPS.

President Laurier addressed meeting on need for all members to be aware of the need to work to prevent problems arising between family branches. He emphasized his wish to see nothing said or done to cause individuals embarrassment.

DISCUSSIONS ON BOOK.

Members discussed in general terms the ultimate aim to achieve publication of a complete history of Donald & Christina McLean.

Production of photos in bromide? What does this mean? Size. What are we thinking of? Many different sources are available for book production. Many country newspapers have done this sort of work? What do we know of the Lovegrove family members, involved in printing trade?

President Laurie asked for suggestion to be placed on next AGENDA for reunions to be held at 5-year intervals, perhapa under organization of different family lines.
