#### AIMS OF COMMITTEE.

HISTORY OF ALFRED PARKER McLEAN, born 5/5/1920 resides 13 Nimboya Road, Marino, SA. 5049

Descended from Donald and Christina McLean, by John McLean and Edwin James McLean, Alf was born in Strathalbyn, being eldest son of Edwin and Olivia McLean.

He grew up on Edwin's farming property "Maplemore" at Angas Plains, south of Strath-This property of 740 acres, was situated opposite John's "Waterloo" homestead, and comprised land on each side of the main road extending southwards towards Milang.

In 1938 at the age of 17 years Alf joined the SA Police Force as a Junior He completed training in 1941, and served in South Eastern, Metropolitan and North Western Divisions, being appointed Officer-in-Charge, Kingoonya Police Station in 1950.

Alf married Miss Lola Blackman, of Ararat, Vic, in 1953 and was transferred to Cowell on Eyre Peninsula. He also undertook the duties of Secretary, Cowell District As a Senior Constable in 1956, he received a Commendation from Commissioner for unusual physical courage and exceptional tact in the single handed unarmed arrest of an armed offender at Cowell.

Later in 1956 he resigned from the Police Force on appointment as the District Clerk, District Council of Franklin Harbour, occupying that position until 1974 when he resigned from the Council to become Chief Executive Officer, of Glenelg District Community Hospital in Adelaide. He retired at age of 65 years in 1985.

During his Police, Council and Hospital career, Alf received considerable support and assistance from his wife, Lola, in her capacity as a trained nurse.

Alf regards a highlight of his career, as being invited to return to Cowell in 1982, to officially open the new District Council Chambers in Main Street, Cowell.
